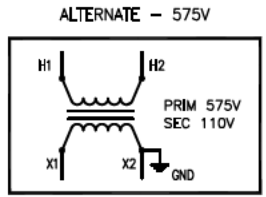
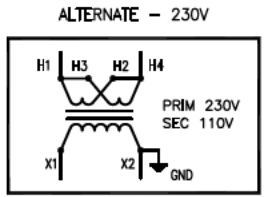
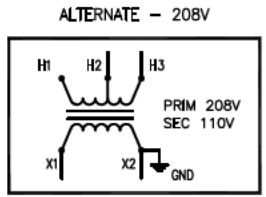
If an overload or fault current interruption occurs, circuits must be checked to determine the cause of the interruption. If a fault condition exists, the current carrying components should be examined and replaced if damaged, and the integral current sensors must be replaced to reduce the risk of fire or electric shock.

More than one disconnect switch may be required to de-energize the equipment before servicing.

The opening of the branch circuit protective device may be an indication that a fault current has been interrupted. All current carrying parts and other components protected by this device should be examined and replaced if damaged. If burnout of a current element of an overload relay occurs, the complete overload relay must be replaced.
